WRITTEN AGREEMENT FOR OUR REFERRAL PARTNERSHIP PROGRAMME (EFFECTIVE FROM 29/08/2018)

WE AND YOU AGREE ON THE FOLLOWING TERMS AND CONDITIONS:

- 1. The partnership is based on a relationship to refer potential clients to Luv Immigration for representation services and for Luv Immigration to reward you for your efforts.
